The Visitor will also be responsible for any damage to the Cemetery incurred in connection with the Group's visit to Graceland Cemetery.

3) The Person in Charge of the Group has the responsibility to keep order during the Group's visit. Only three members of the Group are to be in the Reception Room at one time to use Graceland's lavatory facility. Any unruly or other behavior deemed unacceptable will be cause for ejection of the Group from Graceland Cemetery. These rules will be strictly enforced with no exception. Your cooperation will be appreciated.

4) To the fullest extent permitted by law, the "Visitor" will indemnify and hold harmless Graceland Cemetery from any and all damages, claims, liability, cost or expenses (including attorneys' fees) of any person, including any member of the Group, for any cause whatsoever in connection with the privileges granted to the Visitor under the Agreement.

“Rules for Visitors”

*Graceland Cemetery is a private cemetery that is open daily to the public
from 8:00 am until 4:30 pm.*

All visitors entering the Cemetery must conduct themselves in a respectful manner.

Tour Groups must register in advance for approval of their visits and must sign in at the Cemetery Office upon arrival.

Tour buses and other large vehicles are not allowed to enter or to be driven into the Cemetery.
Drop-off can occur on Clark Street - north of the Cemetery entrance.

School Groups: Students must stay within their assigned groups and with adult supervision in each group. Independent projects for each student are not allowed.

Only passenger cars are permitted to access or park in the Cemetery and they must be driven at a reduced speed of 20 m.p.h.

Cars may only be parked on the road—not on the grass.

Bicycles, motorcycles, scooters and mopeds are not permitted. They should be parked at the gate area. There is a bicycle rack provided at the Waiting Room. Personal Mobility Vehicles (PMV's) are allowed but users are requested to register in the Cemetery Office.

Stone rubbing is prohibited.

Climbing upon monuments/markers or trees is prohibited.

Only still photography using hand held cameras is permitted. No novelty photography as the photographing of funerals in the Cemetery.

Do not disturb plant life or damage any monument or structure in the Cemetery.

Recreational activities, including jogging, rollerskating, rollerblading, skateboarding, ball playing, Frisbee use and the playing of musical instruments are not permitted within the Cemetery.

No food and beverage.

No student drivers practicing in the cemetery.

No fishing or swimming in Lake Willowmere and no **walking or skating** upon its ice.

No blankets, towels or lawn chairs of any sort are permitted.

No feeding of wildlife.

No pets or animals, with the exception of assistance dogs, are permitted on the premises.

Your cooperation with the above rules will be greatly appreciated.
